This agreement is between "You" the merchant and collegeTKTS LLC, the brand owner of MyUCards.com "we".

1. MyUCards is a discount program as set forth on Attachment A. It's controlling company, collegeTKTS LLC reserves the right to change the name at any time without any prior notice being given to any parties.
2. You are agreeing to offer a discount on our Collegiate Discount Card Program. As a merchant there is no fee for you to offer a discount in our program and you may add a discount at any given point. You may not change your original discount unless one of a higher value is being offered. We reserve the right to not allow you to change your original discount and to remove you from the program at any time. You agree to offer this discount until August, 31 2014.
3. We reserve the right to use your discount, logo, slogan, etc. on any and all of our websites, cards, apps, marketing materials etc. We request that you send us a copy of your logo, but if one is not made available to us we will use a logo that we find online.
4. You agree to allow us to use your name and logo to promote the sale and usage of our membership/discount card program.
5. You understand and acknowledge that you have no entitlement to any of the funds we collect by selling our discount cards and membership to our discount program. You do not receive any form of compensation from offering a discount with us and will never ask us for any compensation. You agree to allow us to use your discount, logo and name for marketing purposes.
6. As a participating merchant, you agree to display any MyUCards or (current brand name) marketing materials in your shop such as stickers, napkin folds, business cards, etc. When these items are made available to you, you agree to place them in a visible and favorable location in your place of business.
